## Winchester Country Pool Rules 2024

- 1. All Rules apply to Adults and Children (Homeowners / Renters / Guests)
- 2. Only registered Winchester Country residents and their guests will be allowed to use the pool and tennis courts. You must have a zero balance on your account and a yearly registration form must be on file in the Office at the pool.
- 3. Must have your own working card to enter the pool. Guards will not open the gate for anyone. You may not enter with someone else's card. You must scan card and sign in.
- 4. All guest (includes neighbors with no card) will be charged \$1.00 daily.
- 5. The number of guests is limited to 4 guest per homeowner, a household member who must also be at the pool. (Guest is anyone without a card even if they live in the neighborhood and any family member visiting your home)
- 6. The telephone in the guard office is for emergency use only.
- 7. Children under 10 must be accompanied by an adult (18 years or older). (Not older siblings)
- 8. The baby pool is restricted to non-swimming children who are under the age of 6.
- 9. Non-swimming children must stay within arm's reach of an adult in both the baby pool and large pool. Even if they have on life jackets. Only 2 non-swimmers per adult will be allowed.
- 10. All non-potty-trained children must wear swim diapers at all times provided by the Residents.
- 11. Parents or guardians are responsible for children and/or guest in both the baby pool and large pool at all times. Life guards are there for your safety
- 12. Running is not allowed in the pool area. No horseplay will be tolerated either in or out of the water. No throwing hard balls or objects in the pool area. No rafts allowed.
- 13. Glassware/glass containers are not allowed in the pool area. No alcoholic beverages are allowed in pool or on the ground. No grills allowed. Users of the pool are responsible to clean their area and use facility trashcans to discard their trash. No Red Dye products.
- 14. Abusive/offensive language or gestures, racial slurs will not be tolerated. No music allowed wear your earbuds (not everyone likes the same music)
- 15. Smoking is not allowed in the fenced area of the pool facility. There are designated smoking areas in front of the coordinator office and clubhouse II.
- 16. All persons younger than 18 years of age will leave the water during the scheduled hourly lifeguard break/adult swim period and sit away from the pool edge. (Feet out of the water).
- 17. All swimmers must wear swim suits. No cutoffs or regular clothes are allowed.
- 18. Only Coast Guard approved floatation devices will be allowed and must be approved by the lifeguard staff. All non-swimmers must wear coast guard approve floatation jackets.
- 19. Person with bandages and/or open sores will not be allowed in the pool
- 20. Cocoa butter, baby oil or other similar products will not be allowed in the pool. Commercial suntan preparations only.
- 21. No animals are allowed past the front gate of the pool area.
- 22. The Association is not responsible for lost or stolen items or unclaimed items on the "Lost & Found" shelf. Unclaimed item will be disposed of throughout the pool season.
- 23. No climbing on the shade awning support poles or perimeter fencing.
- 24. On diving board, 1 person on board and 1 person at the bottom of the stairs until diver jumps into the water and reaches the edge of the pool side. No trick diving.
- 25. Use of diving board will only be allowed when Guard closes deep end and opens up board. Must request to have diving board open to jump off.
- 26. The lifeguards on duty will have the final authority for the enforcement of pool rules and the overall safe operations of the facility both explicit and implied by the Pool rules and must be obeyed at all times by adults and children
- 27. Any undermining of Guard's Authority (explicit or implied) or disrespect toward guard will not be tolerated.

## **DISCIPLINE**

Infractions to pool rules will result in disciplinary action taken by the contracted pool management company and/or Winchester Country Board of Directors. Disciplinary actions may include time out and/or suspension of cards from one day up to and including the remainder of the pool season for Adults and Children. The actions of one will cause entire card household to incur the disciplinary actions.
